Diversity in the Workplace

• City of Belleville and UNAC Diversity/Inclusivity event held at Albert College last year was a success and there will be a new event in the early evening of May 08, 2014 focusing on Diversity in the Workplace at Loyalist College – Guest speaker Mr. Michael Bach, Human Resources/Diversity, Director of Diversity, Equity and Inclusion KPMG LLP - Information to follow.

Labour Market Outcomes Strategy: QUIS & Community Employment Services – Loyalist College CES

- Joanne Leith Employment Consultant from Loyalist College Community Employment Services provided an overview of the strategy such that Joanne attends QUIS on Thursday afternoons for booked appointments or drop-in's providing advice to newcomers who do not normally attend employment offices. In this comfortable atmosphere success has flourished in terms of employment prospects for newcomers. Joanne has met with a variety of people with different visa statuses (some visitors, some PRS, etc), and varying language abilities. Outcomes have varied. Related anecdotal examples of client success e.g. discussing interview approaches prior to a client's actual interview client got the job. In addition, has been able to refer/connect clients with other important service providers. Sometimes the meetings just help to boost clients' confidence, so the 'warm hand-off' does help. Challenges: Newcomers don't have networks. CES can only offer certain assistance depending on visa status, and must curtail/withhold some services. E.g.: work permit holders cannot get subsidies. Some of the clients are students so not all are unemployed. The partnership with QUIS is working well.
- Orlando Ferro added that we will have a better idea of our client's employment situations after we have completed our work on the <u>QUIS database</u>*

QUIS Data Base Development*

- QUIS has embarked on a new endeavour mapping a data base of employers and a data base of the
 employable skills available within the QUIS client database of some 1400. The research is being
 conducted by:
- Jeff Wildgen Research Coordinator QUIS discussed the work he is involved in at QUIS on building a database of employers in the Quinte area and the skills in demand.
- Julie Tang Research Assistant QUIS data base of the employable skills available within the QUIS client database.
- Karen Poste Manager, Economic & Strategic Initiatives City of Belleville advised on the City database "Belleville Wants You" and the possibility of sharing information
- QUIS will update and share its information with municipalities within the Bay of Quite region

New immigration policy drastic changes

• Orlando Ferro: the changes will include citizenship rules, length of wait time, who is eligible, citizenship can be revoked, etc. Announcements made about employment programs, now have a clearer idea. Seems there will be two parallel funding sources: federal and provincial. April 14, the agreement expires, will keep watch on the news and developments.

Professional accreditation question

- The guestion was asked if the QUIS mandate included professional accreditation for newcomers.
- Response: Orlando Ferro This is currently not a part of the QLIP mandate but perhaps in the future.

Destination Canada

• This is an initiative of Citizenship and Immigration Canada, which helps employers attract and recruit bilingual foreign professionals in a streamlined and accelerated manner to deal with their labour market shortages. QLIP Making Progress?

• The question was asked if the QLIP Partners are making progress in terms of its goals - "round table".

Comments included:

- Marcela Klein-Rezac: Feels there is raising awareness of immigrant issues, feels great progress has been made
- Carmela Ruberto: We are immersed in it so maybe we can't see the progress as well as others. But wonders if the general public at large sees progress, changes.
- Karen Poste: Is happy to see its working. Sees a paradigm shift in how business views immigration.
- Orlando Ferro: Was shocked to see a meeting of mayors receptive to immigration a significant change
- Jeff Wildgen: TVCOGECO Cable 4 documentaries have helped to bring awareness; we need more of the same, more education and public relations.
- Janice Faires: Sees the community coming together more. The next 3 to 4 years are crucial. Exciting to see organizations working together like this. Young people are coming back to the community.
- Mike Hewitt: Agrees that these efforts are helping to attract people in general, even if the original intention was for immigrants, so it's good. We can leverage these ideas to attract more people to the area.
- Paul Osborne: Was born here and sees lots of progress, and a paradigm shift, no doubt there is dynamic progress being made.
- Darrell McGrath: Biggest challenge for newcomers is 'Canadian Work Experience', communication skills, cultural familiarity. Expectations need to be adjusted if cannot use their higher skills immediately. Layoffs put more pressure, plus new grads entering labour force, creates further difficulties.
- Joanne Leith: Newcomers have stated they have to work ten times harder than a local worker, so employers should see that as a benefit to their business.
- Mike Hewitt: Foreign Trained Professionals work ethic is better than some of our own younger people, so employers should weigh that against any issues about foreign credentials, etc.
- Orlando Ferro: Mentoring Programs are a good idea; many other areas have them, but they are still lacking here. Let's start talking about that.
- Aruna Alexander: In Belleville in 1976 one could not even talk about immigrants. Have seen much change since then. Happy to be working with QLIP Partners. The City of Belleville, Mayor Neil Ellis and Karen Poste helped so much with the antiracism efforts.
