#### LIP PARTNER ACTIVITIES, INITIATIVES AND DELIVERABLES

- QLIP Meeting Tuesday June 09, 2015 at Career Edge in Napanee
- Career Edge accommodated the QLIP meeting which brought local community organizations, the Town of Greater Napanee and the County of Lennox and Addington together for discussions around Immigration.
- The representative from Career Edge advised the QLIP Coordinator upon completion of the
  meeting advised how important it was for newcomers to the area to find stable housing, to
  access ESL services and to find employment. She also noted that one of Lennox and
  Addington's heaviest new Immigrant' areas is north of highway seven or the northern part of
  the County.
- Deirdre McDade a Lawyer at Community Advocacy and Legal Centre CALC delivered a
  presentation outlining the services provided by CALC and services provided by Legal Aid

  in concert with the City of Quinte West and Prince Edward County.
