DISCUSSION

Introductions and opening remarks

- Acknowledgement Special appreciation to Karen Post Manager of Economic and Strategic Initiatives City of Belleville and the City of Belleville for their provision of the Sir Mackenzie Bowell Meeting Room at Belleville City Hall.
- Carmela Ruberto "Situation Table Community Safety and Well Being Committee"
- Members from 31 vital organizations in Hastings County meet weekly to work together on situations that
 require rapid interventions to support individuals and families who are in high risk situations. 40 cases were
 acted on in 2017. Community Safety and Well Being Committee Situation Table FACT Form 2016 information
 provided on the Situation Table.
- The group finds system efficiencies to help at-risk families receive the community resources needed.
- "By bringing the agencies together, we can form a multi-agency intervention using the four filters of information sharing, with very positive outcomes."
- The four filter model that the agencies uses to share information includes individual agency screening, determining risk with de-identified information, limiting disclosure of agency recognition and door knock intervention.

- Stella Weese Victim Services of Hastings Prince Edward and Lennox & Addington Counties an in-depth overview of services was provided, more information is available at: http://www.victimservicesquinte.ca/about.html
- Victim Services offers 24 hours a day, 7 days a week short term crisis support and is the only agency in the
 Quinte Region providing immediate on-site crisis, trauma, safety and support services to victims in response
 to the needs of individuals, families and communities affected by crime and sudden tragedies. Service is
 provided in all communities in Hastings, Prince Edward, Lennox & Addington Counties. They offer practical
 assistance, information and a referral program to victims.

 Quinte Immigrations Services will be seeking support from community partners in its application for this grant in relation to gaps in services to newcomers to the Quinte Region.

- QUIS http://www.quinteimmigration.ca/ relies on partnerships to amplify the response to vulnerable newcomer communities. Partnerships can fill gaps in services for newcomers. The QUIS partnerships includes the Belleville Public Library that provides a space for a QUIS Settlement Worker to offer information to individual newcomers on Thursdays from 4pm to 7pm including those who cannot come to the QUIS offices in the daytime hours, have accessibility issues and those who may be using Belleville Transit to reach services like the Belleville Public Library. There is a need for increased partnerships in order to fill gaps in services to newcomers many of whom are in vulnerable situations, open to fraud and exploitation.

 on the Belleville Inclusion Committee (BIC) and on developing strategies for diversity awareness and
 inclusivity and how to create the climate of inclusivity to counter racism and discrimination including
 Vigilance, Community involvement, Education, Marketing/Communications and more.

- **Volunteers and Information Quinte** Discussions on the need for partner information on the BIC and other Partner agencies prompted a discussion on the services available from VIQ
- VIQ database of all agencies ability to broadcast to all agencies, information to a vast number of agency connections in the Quinte Region.
- Volunteer and Information Quinte has the capacity for reaching the general public and provides a central
 focus for agencies and volunteers. VIQ maintains a database of possible volunteers for hundreds of agencies,
 and a volunteer for the 211 Ontario support line. Agencies needing assistance in "getting the word out" can
 contact VIQ as they have the ability to "broadcast" information.
- Transportation to ESL classes at Loyola has been a persistent struggle and VIQ may assist in finding solutions.
